Environmental protection:

(1) Crops/situations with >5m buffer zone:

Since there is a risk to aquatic life from use, do not allow granules from application equipment to fall within the distance specified for the crop of the top of the bank of any static or flowing waterbody or within 1m of the top of a ditch which is dry at the time of application.

- (2) Buffer zones must be measured in accordance with the guidance set out in the booklet 'Local Environment Risk Assessment for Pesticides -Horizontal Boom Sprayers' available from HSE Chemicals Regulation Division's website and any amendments made to it.
- (3) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied).

Other specific restrictions:

- When used on crops/situations with a greater than 5m aquatic buffer zone this product must not be applied via hand-held equipment.
- (2) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (3) The seed or any part of treated plants must not be used for human or animal food or feed (except game birds).

APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION
