ADVISORY INFORMATION

IMPORTANT: When applying this product under the terms of this Extension of authorisation, comply with any resistance guidance or restrictions stated on the product label. Total reliance on one pesticide will hasten the development of resistance. Pesticides of different chemical types or alternative control measures should be included in the planned programme. Alternating with different modes of action is a recognised anti-resistance strategy.

Strains of some annual grasses (e.g. black-grass, wild oats and Italian rye-grass) have developed resistance to herbicides which may lead to poor control. A strategy for managing and preventing such resistance should be developed. Guidelines have been produced by the Weed Resistance Action Group and copies are available from the HGCA, CPA, your distributor, crop advisor or product manufacturer.

This Extension of authorisation relates to the use of 'Avadex Factor' (M17877) for the control of black grass, Italian ryegrass, loose silky bent and wild oats in Corn Gromwell. Application is to be made via horizontal boom sprayer in 200-300 litres water per hectare.

Extreme care must be taken to avoid spray drift on to non-crop plants outside of the target area.

APPENDIX 1: CONDITIONS OF EXTENSION OF AUTHORISATION

The conditions below are obligatory. They must be complied with when the Extension of authorisation occurs. Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution. For the purposes of this Extension of authorisation only, the conditions and/or requirements shown below supersede any corresponding conditions and/or requirements set out on the label or otherwise provided for under the product authorisation which would otherwise apply.

Operator Protection:

(1) Engineering control of operator exposure must be used where reasonably practicable in addition to the following personal protective equipment:

Operators must wear suitable protective clothing (coveralls) and suitable protective gloves when handling the concentrate.

(2) However, engineering controls may replace personal protective equipment if a COSHH assessment shows that they provide an equal or higher standard of protection.

Environmental protection:

- (1) Horizontal boom sprayers must be fitted with three star drift reduction technology for all uses.
- (2) Crops/situations with >5m buffer zone:

Since there is a risk to aquatic life from use, direct spray from horizontal boom sprayers must not be allowed to fall within the distance specified for the crop of the top of the bank of any static or flowing waterbody or within 1m of the top of a ditch which is dry at the time of application.

Spray must be aimed away from water.

- (3) Buffer zones must be measured in accordance with the guidance set out in the booklet 'Local Environment Risk Assessment for Pesticides Horizontal Boom Sprayers' available from HSE Chemicals Regulation Division's website and any amendments made to it.
- (4) The results of the LERAP must be recorded in written form and must be available for a period of three years for inspection to any person entitled to exercise enforcement powers under or in connection with the Plant Protection Products Regulations 2011 or the Plant Protection Products (Sustainable Use) Regulations 2012. (An electronic record will satisfy the requirement for a written record, providing it is similarly available for inspection and can be copied).

Other specific restrictions:

- (1) This product must not be applied via hand-held equipment.
- (2) This product must only be applied in accordance with the terms of this extension of authorisation, the product label and/or leaflet and any additional guidance on extensions of authorisation.
- (3) Buffer zones greater than 5m are NOT eligible for buffer zone reduction under the LERAP scheme.
- (4) Low drift spraying equipment must be operated according to the specific conditions stated in the official three star rating for that equipment as published on HSE Chemicals Regulation Division's website. These operating conditions must be maintained until 30m from the top of the bank of any surface water bodies.

APPENDIX 2: GENERAL CONDITIONS FOR AN EXTENSION OF AUTHORISATION

Failure to comply with the following conditions will result in the withdrawal or amendment of the Extension of authorisation under Regulation (EC) No 1107/2009 and may result in other enforcement action, including prosecution.

Adverse effects:

The authorisation holder must immediately notify the Secretary of State, the Welsh Ministers, the Scottish Ministers and the Department of Agriculture, Environment and Rural Affairs in Northern Ireland (care of the Health and Safety Executive), if they have any new information on the potentially adverse effects of the authorised product, or of residues of an active substance in that product when used in accordance with the conditions of this authorisation. For those products authorised under Regulation (EC) No 1107/2009 as it has effect by virtue of the Protocol on Ireland/Northern Ireland in the EU withdrawal agreement, authorisation holders must also tell the other relevant competent authorities of the EC Member States (a list of which is available from the Health and Safety Executive) and the EC Commission. Failure to comply with this requirement is an offence.

Provision of information:

The authorisation holder must comply with all requests for information required by, or on behalf of, the Secretary of State, the Welsh Ministers, the Scottish Ministers or the Department of Agriculture, Environment and Rural Affairs in Northern Ireland in accordance with Regulation (EC) No 1107/2009.
